1. Introduction.

This report on fish farming in Iceland contains statistical informations about the production in fish farming for 1991.

Included is all available information about production of salmon, trout and char in 1991 as reported by each company. All quantitative informations presented in this report is provided by the managers of the various fish-farms.

The production in salmon farming is categorized as rearing of juveniles, on-growing for consumption market and ocean ranching. Smolts are by definition the end product in the rearing of juveniles and all reared smolts i.e. smolts for on-growing and ocean ranching are included in the production figures unless they have been sold from the farm as pre-smolts. Salmon for the consumption market is reared in land-based tanks, in seacages or a combination of both and also by ocean ranching. Ocean ranching is defined as the aquaculture system in which juvenile fish (smolts) are released to grow on natural food in marine waters from which they are harvested at marketable size.

The export value of the Icelandic aquaculture industry production in 1991 is amounted to be 1010 million Icel. kronas, which equals almost US\$ 16 millions. The industry employed 227 people directly.

2. Production capacity of Icelandic fish farms.

Registered fish farms in Iceland are today 75 compared to 92 in 1990, 105 in 1989 and 125 in 1988.

Fish farms that product pre-smolts and smolts are 50 with total production space about 48.900 m³ (table 1). That production capacity enables production of about 14,7 million smolts a year, given that 60% of the capacity for juveniles are used for smolts and production of 500 smolts per cubic meter.

On-growing farms are 30 with total production space about 325.000 m³ (table 1). The actual production capacity of existing fish farms in Iceland is estimated to be about 374.000 cubic meters.

Ocean ranching sites is registered 14 in Iceland today. The number of smolts realeased in salmon ranching in 1991 were approximately 6 millions compared to 5,6 millions in 1990, 4 millions 1989, 2 millions 1988 and 1 million smolts released in 1987. The forecast for 1992 is that 6 millions smolts are to be released in ocean ranching in Iceland.

3. Production in 1992.

3.1. Salmon production.

The production of salmon smolts for 1991 was 7.247.000 smolts and 1.313.000 super-smolts. Of the total production, 8.561.000 smolts, 6005 was released in ocean ranching and 2.556.000 was used fore the land-based on-growing process. The total number of smolts in 1991, 8.561.000 (table 2) are comparable to the total number of smolts in 1990 (8.147.000).

The total production of salmon for the consumption market have increased in recent years (table 3). Total production is here given as the total amount of salmon that was slaughtered and sold in given year (table 3). The production from on growing process is also given by increase in biomass, wich is drawn from the amount of salmon in on-growing process in the beginning of particular year plus total amount of fish slaughtered from on-growing farms in the same year, minus the amount of salmon in on-growing process in the end of the year.

The total production of salmon for the consumption market in 1991 are comparable to the total production in 1990 (table 3). The forecast for total salmon production in 1992 shows expected increase in production from both on-growing process and ocean ranching (table 3). Rise in salmon production in 1992 are expected both in farms that use

the on-growing process and in salmon ranching. Expected increased production from on-growing farms are mostly due to larger amount of salmon in the beginning of 1992 (2.212 tonnes) than in the beginning of 1991 (1996 tonnes). This forecast is based on that the proportion between amounts of salmon in on-growing process in the beginning of the year and the amount of salmon slaughtered in same year will be nearly the same as it has been in past three years.

Recaptures of ocean ranched salmon is expected to be better 1992 than last three years in relation to data from the Marine institute which shows that sea conditions have been good since spring 1991 compared to bad sea conditions last three years. The forecast for production in ocean ranching of salmon 1992 is based on that 4-6% of grilse (mean weight 2,4 kg) will be captured and 0,7% of multi sea winter salmon (mean weight 5,7 kg). Total production of salmon 1992 from ocean ranching is estimated 797 - 1.086 tonnes.

3.2. Trout production.

The production of trout in 1991 was 307 tonnes. Three species of trout are farmed in Iceland, rainbow trout, arctic char and brown trout. The proportion of each species in the trout production 1991 is showed in table 4 together with forecast for production in 1992.
